1. Conformation is open to all pure-bred dogs 3 months of age and older, that **do not have** major points.
2. Agents/professional handlers are only allowed to handle dogs that they own or co-own.
3. Wins carry no championship points.
4. Dogs must be in proper show clip. No taped ears are allowed. Spayed or neutered animals **MAY NOT** compete.
5. Dogs must **ALWAYS** be on a leash or be crated except when being judged.
6. Keep the park clean so it will be available in the future. Dog scoops will be provided by CVDFFA.

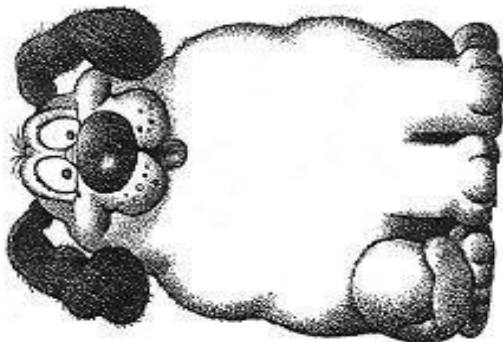
